Passive Tip of the Month

Why make it up and take the risk?

It is clear that the Acceptable Solutions require fire stopping systems to be installed that are tested to AS1530.4 and AS4072.1. Manufacturers may also have systems tested to other standards that are assessed to the above AS Standards.

When working on existing buildings and due to existing installation of services / lack of access, there are often occasions where no AS systems are available to complete the fire stopping of services through fire separations.

For consented work you will then need to speak with the manufacturer of fire stopping systems and ask them to provide an 'Engineering Judgement' using a design that will intend to achieve the required Fire Resistance Rating. This Engineering Judgment is then required to be submitted to Council as a minor variation to consent.

If you install fire stopping systems outside of their tested parameters without talking with the manufacturer as above then you are taking a huge risk. Use manufacturers knowledge to your advantage.

In the past month on jobs I have been involved with, two passive installation companies took it on themselves to 'make systems up themselves without discussions with the manufacturer'. This has added additional costs to their project (have to re do the work) and unnecessary risk that could have been avoided.

Don't take the risk talk to the manufacturer. Remember though EJ's apply when there is NO tested system available.

MBIE Reviews

Next month members of the FPA will commence meetings with MBIE and other parties for the following: Passive Fire Protection, Construction Monitoring and Post Construction Monitoring.

Fail of the Month

Fire Rated Dampers are required to be tested every 5 years or as per the Compliance Schedule. While this is on old fusible link damper it is obvious that it has not been tested for a long time!

HVAC companies / IQPs need to check risers for such issues and have fire rated dampers listed on the Compliance Schedule.

Evacuation Consultants Group Update

In recent times, the current legislative alignment environment has highlighted the need to get legislative savvy. Hence, as a 'warm up' to our next upcoming technical session with the topic 'Mitigation when selecting assembly areas' in mind, I drafted this letter. I look forward to Nicky Vaughan sharing with us from her health & safety perspective.

I like to believe that most Evacuation Consultants would readily embrace the philosophy to obtain sound knowledge and expertise in the variant ways of how to proceed in matters of evacuation, relevant to occupancy and in the context of building. In my mind this entails solid knowledge and familiarity in building and fire industry's technical terminology, its policies, processes, documentations and its governing legislative framework in the overarching context of fire safety.

Thinking of governing legislation relevant to our sector, let's take for an example the regulation, which speaks of a 'place of safety' outside and or inside. To enable to reach this place, a 'staged', horizontal, progressive, fractional and or 'a one out-all out' evacuation strategy and its distribution channel of information is formulated.

The practical application is influenced by the building and fire design, legislation documents, building structure, features and its occupancy. Complexity levels are varied in relation to the complexity of building structure and its use. Complex enough right ☺ however it gets even more complex when sets of other relational rules are being added into the equation. This is where we find ourselves considering the workplace safety regulation under the New Health and Safety in Work Act 2016. (HSWA)

Let's reflect on the Health and Safety at Work General Workplace Management Regulations 2016. Part 1 Regulation 14 under the heading 'Emergency Plans' and subheading 'Duty to prepare, maintain, and implement emergency plan', regulation 14(1) outlines, who is to take up the role of ensuring an emergency plan exist and is to ensure implementation in accordance. Regulation 14(2),(a-c) states what must be included in the procedures, while 14 (3) is requiring effectiveness of the plan and its maintenance. Regulation 14 (4) sets the contextual 'scene' and 14(5) states the need to implement the plan in the event of an emergency. Finally in regulation 14(6) we find outlined the consequences for a BCPU in the event of breach of these.



This leads to the question does the role as a contracted consultant conducting a business or undertaking could be seen as BCPU? If so, under what circumstance and what are the implications?

WorkSafe defines a BCPU as a person conducting a business or undertaking. Accordingly an individual, such as a sole trader or self-employed person could be a PCBU. Business is defined as an activity carried out with the intention to making a profit or gain. The HSWA states duty of care as a business or undertaking must ensure so far as reasonably practicable the health and safety of its workers and that of other people are not put at risk by its work.

Under that definition; so far as is reasonably practicable we also find the role of Duty holder and a raft of relational responsibilities, the word officer referring to due diligence matters in relation to ensuring the safety of people is mentioned to. Are those specific roles relevant to us and if so, how?

For example, does consultants' responsibilities to the contracting person(s) include the provision of all relevant information necessary to enable informed consent? Is this a part of the expectation to minimise risk and ensure the safety of people in the event of fire? Think for an example of my previous update and the story about the little innocent orange sprinkler head clamp.

I hope I warmed you up to take this fantastic opportunity to come prepared to ask Nicky some questions and be enriched by her wealth of knowledge in health and safety legislation.

In the mean time may all be well in your world.

SURVEY UPDATE

The FPA NZ Council meeting was held in Auckland on the 21st July it was great to receive feedback from the New Zealand Fire Services National Risk Manager Todd O'Donoghue in regard to the Hand Operated Fire Fighting Equipment, the full survey findings are now endorsed by the Fire Service and the complete findings can be published.

This is a major milestone for the industry and supports all of the hard work completed by all, we will be discussing the best way to publish, educate and distribute the report at the special interest group Monday August 15th at 10.00am at the FPA NZ Office, 9C William Pickering Drive, Auckland City.

WORKSAFE NEW ZEALAND

The HOFFE Special Interest Group initiated a meeting with Kim Comben, Principal Specialist Hazardous Substances Worksafe New Zealand. This was an opportunity for the importers to have discussion around Fire Extinguisher cylinder compliance in New Zealand for both the importer and service providers.

The group would like to see better communication between FPA NZ, Worksafe and CTLA (Cylinder testing laboratory association) in the future the areas of concern are listed below.

- CO2 Extinguishers are required to be inspected by a Test Certifier who will issue a Cylinder importation compliance certificate in accordance with Hazardous substances (compressed gases) regulations 2004 when they are in the country and this completes their legislative requirements.

- Issues that arise particularly around any recharge or testing facility which falls under the CTLA is that there is no consistency and the gas regulation rules apply irrespective if they are practical for a CO2. i.e. the amount of markings required on a normal gas cylinder valve is a lot more than can actually fit on a CO2 valve and the valves do not have the same operating mechanisms.
- The testing of the cylinders integrity during the refilling process is also full of inconsistencies between CTLA members particularly when one member has the most advanced crack detection system that shows flaws that deem the cylinder unfit for use and is labelled as such but in fact this is not the case with other CTLA members these inconsistencies need to be addressed as cylinders are been condemned at first test?
- Regulation 44 of the Hazardous Substances (Compressed Gases Regulation 2004 Currently the Hazardous Substances Regulations are being re drafted. An opportunity exists to address any anomalies in respect of valves for carbon dioxide fire extinguishers.
- In respect of the discussion over shrunk on foot rings this requirement should not apply to low pressure fire extinguishers as the foot rings are pressed on rather heated and then allowed to contract around the cylinder body. This interpretation will need to be replayed to the CTLA to ensure consistency in testing.

HOFFE Code of practise is currently in a draft stage and to be released for comment.

NZS4503:2005 the cost to amend the standard is potentially a 100-150K budget which will need to be funded by interested parties I am currently in discussions with Chris Mak in regard to this process and timing.



Contractors Group Update

At the last Board meeting on the 19th May it was discussed that due to the continued vacancy of the Contractors SIG Chair we would appoint a temporary Chair to get things moving again. The national council suggested that I should step into this function until such time as a contractor wishes to hold this position.

The meeting was held in the FPA office 13th July the main agenda were around how to engage with contractors more, skills training for the industry and what other topics are important to the group and contractors as a whole. A very small team will review contractor's desires for effective training later this month. It is expected that an emphasis on delivering block-course training in addition to the current theoretical training delivered via Firetech will be one of the most significant outcomes.

Another topic discussed is the need to amend various standards. A number of designers will be meeting in Auckland later in August to review issues they face in the use of NZS4541. We will also be scheduling a meeting, probably in September, in Christchurch. If there is enough feedback from Wellington contractors wanting to participate is the same discussion, then we will also have a meeting there.

Other standards that the Association propose need reviewing include NZS4512, and NZS4510.

The next Sig Meeting will be on 7th October 2016. I encourage you to attend the next meeting so we can align our objectives as a group and prioritise these to enable the contractors group to get some good outcomes. The Association's Board is committed to adding value to its contracting members.

Submissions Wanted

The FPA has been approached by the Specialist Trade Contractors Federation to contribute to a review of SA-2009 Subcontract Agreement. To this end we are seeking the input of our members and will consolidate these for presenting to the Specialist Trade Contractors Federation. Please see below some background on what the review is looking to achieve.

In the 7 years since its introduction, little feedback has been received indicating a need for any significant changes which is a reflection on the work of the original working group in delivering a document that required compromise from both sides.



This review is principally to accommodate changes to the Construction Contracts Act, but it is an opportunity to consider any other changes. We would welcome your thoughts on realistic changes that could be considered in this review.

Payment in full within 7 days and no retentions would be great, but is not going to be accepted as a standard requirement in the document, although SA-2009 as written does accommodate such conditions to be incorporated in the "Specific Conditions" if the parties agree. The "Specific Conditions" accommodate most variables that are likely to be wanted, and if not they can be covered in "Special Conditions"

Get to Know the FPANZ Council

The main roadway was elevated directly above the commercial road and both were connected by footpath areas to the buildings therefore forming a tunnel structure.

Apart from all the work above, I do enjoy being in Gisborne as it provides me with the great outdoors life for my family and I. Here we are able to enjoy fishing, hunting and freedom camping along the coast.



Avoiding the Potholes of Fire Sprinkler Design - No. 2

Aon has prepared a series of articles to help those designing a sprinkler system arrive at the right design decisions and avoid costly time consuming problems.

Continuing from article 1 in the July newsletter we now delve into the ordinary and not so ordinary. Evaluating if the space is Extra Light Hazard (ELH), Ordinary Hazard 1 (OH1), Ordinary Hazard 2 (OH2), Ordinary Hazard 3 (OH3), Ordinary Hazard 3S (OH3S), or Ordinary Hazard 4 (OH4) is normally straight forward. In most cases the building usage fits nicely within the descriptions given in table 2.1 but there are occasional exceptions to the rule.

The classifications in table 2.1 are based upon the performance criteria in 203.2.1 which are:-

- a) The fire load;
- b) The rate of fire spread and development;
- c) The extent of potential fire spread.

Before we take the basic classification given in Table 2.1 as the design solution for the building we have to ask two questions. Firstly are there any individual spaces within the building that do not fit the criteria; these spaces may require a greater or lesser design than the overarching building classification. Some examples may help illustrate this point:-

- ELH office within an EHH warehouse,
- OH2 workshop within an ELH hospital,
- OH3 laboratory within an ELH school,
- Idle pallets (EHH) within an OH3 factory,

Secondly are the room names on the spaces misleading in so far as Table 2.1 and clause 203.2.1 is concerned. By this we mean is what the owner called a space a representation of that space as we would understand it to be. It is these spaces that can cause problems at certification/reinspection time if the space was under designed but equally if over designed the water supply will have been over capitalised. Some examples that have come across my desk recently help illustrate:-

- A building was called a museum (OH3) but on closer inspection it was closer in usage to an Art Gallery (ELH).
- A movie room at a rest home (ELH) but the movie room looked exactly the same as an art house cinema (OH3) including terraced seating.

- The community hall (OH1) which was called a 'multi-purpose venue' whose scope included trade exhibitions (OH3, maybe OH3S) but no 21st parties!
- Whether an old single story timber office building, about 150m², was a commercial 10m separation risk or a domestic 3m separation risk to which I told the contractor "Looks like a house – burns like a house"
- Display of a large model in a retail tenancy (OH3) but the area should have been protected as theatrical storage (EHH process).

Trying to correctly reclassify can be difficult but the easiest method is to benchmark your space off other existing building that clearly fit the Table 2.1 criteria. What you have to do is pick the relevant driver of your benchmark that was key to each part of the three criteria in clause 203.2.1, this is what is meant in the paragraphs two and three of clause 203.2.2. In the example of the museum we bench marked off major metropolitan museums as being examples of what should be OH3 space in terms of multiple floor atriums, complex air flow patterns, large displays and large occupant numbers. We also benchmarked the usage of the museum in question and contrasted that with the public area of Art Gallery's.

We are also asked what is the difference between some of the sub-categories within Public Assembly on table 2.1. To which the answer can be found in the three criteria in clause 203.2.1. My personal favourite is when is a bar (OH1) actually a nightclub (OH3); for anyone who has been partying in Ibiza or Las Vegas the difference is clear – higher fire loads due to sound and lighting equipment with the added use of other special effects such as foam, smoke and pyrotechnics, and quite large floor plates normally spread over multiple floors.

Having correctly classified the design required for all parts of the building there is one more step before you start laying out pipe and sprinklers. What contractual requirements over and above the consent need integrated into the design, and that will be the topic next month.

If there is any topic that an FPA member would like our thoughts upon feel free to email myself and we will look at writing up a discussion about.

Competenz, FPA New Zealand and FPA Australia enters into major training partnership

Competenz are transforming the way the New Zealand fire industry learn with help from the Fire Protection Association Australia (FPA Australia) and Fire Protection Association New Zealand (FPANZ). The partnership will help deliver best practice industry training to the industry through the development of an online learning solution.

forward to offering them to learners and ensuring the best possible learning materials are developed for this critically important industry."

FPA Australia CEO Scott Williams said the move would lead to more consistent educational outcomes for learners in New Zealand and Australia.

"Our vision is reducing the risk of fire to life property and the environment, for a safer community and this agreement goes a long way towards achieving this," he said.

"This partnership will ensure that best practice fire protection industry training can be conveniently delivered to learners in New Zealand and this will greatly increase the portability of skills as individuals move between our two countries."

Scott Lawson, FPANZ Executive Director said the agreement paved the way for closer ties between all the organisations in the future.

"This initiative is just the start of a strong partnership between our organisations to ensure we can continue to deliver for our members and the broader fire protection industry," he said.

"By sharing resources and costs, all learners will benefit and we know we are delivering the best quality industry training available. FPA Australia should be congratulated on the quality of their training materials, which are world class, and we are delighted to be able to access them."

Calling all Halon Fire Extinguisher Owners

FPANZ is promoting awareness around Halon fire extinguishers and wants to recover these from the commercial sector and from private owners.

Halon has fallen out of favour due to its environmental impact and long atmospheric life time. It is considered to be a potent greenhouse gas and contributes to ozone depletion. However, safety is the main issue as servicing of Halon extinguishers has not been available since 1998 when the production of Halon was banned under the Montreal Protocol.

Over the previous ten years, more than 60 tonne of Halon has been recovered by FPANZ members and this was sent for safe destruction. It is estimated that a further five to ten tonne is still in use. This needs to be recovered now as any unit still in use will be well over ten years old and will not have been serviced.

"Fire extinguishers, just like smoke detectors, need to be checked by a certified agent annually" says Blind

"We do have fears that Halon extinguishers, due to this lack of servicing, may fail to operate correctly in the event of a fire. We are prompting all members of the public to check their boats, cars, workshops, caravans and planes to see if they still have a yellow Halon extinguisher and to exchange this for a unit coloured red".

"There will be a cost to change, however both the public and the environment will benefit as we can be sure new systems will operate correctly in event of a fire and the impact on the ozone layer will also be reduced" says Blind.

There are now many suitable and cleaner alternatives available and FPANZ members located nationwide will accept Halon units and provide information on the safer alternatives available. Halon extinguishers are easy to identify as they are bright yellow. Replacement units will be coloured red.

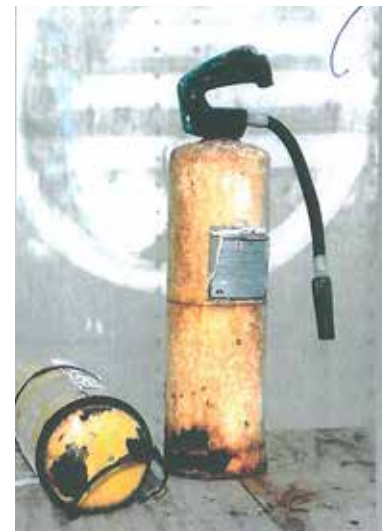
"We look forward to gathering as many of the remaining Halon systems and hand held fire extinguishers here in New Zealand and to have the contents safely destroyed" says Blind.

"We will also have greater confidence that owners will be protected in the event of a fire and this will ultimately protect lives".

Our message is: "Be Safe Yellow is Out – Red is In!"

Yellow extinguishers, Halon extinguishers, are so old – if you have one, the chances are they will let you or your family down in a fire.

Halon damages the ozone layer which in turn can affect our health, causing skin cancer, cataracts and other illness as well. Damaging the ozone layer can also impact on our weather, our soil and our crops.

Protect yourself, your family or business, by handing in your old yellow extinguisher. It's easy to do – simply take it to the nearest local approved Fire Extinguisher Service Agent. A list can be found at www.fireprotection.org.nz



While there, talk to these experts about your needs and how best to protect against fire, including alternatives such as a red fire extinguisher*, a fire blanket, a smoke alarm, and other effective choices. Often a combination is the best approach.

So act now and hand in your old yellow extinguisher. It's a service for the general public and small businesses. A small recovery charge will be set at \$10 per kilogram (up to a maximum extinguisher weight of 2.1 kg in size). A Halon extinguisher larger than 2.1kg is considered a commercial size and will be disposed of at a quoted rate.

Graham's View

This month celebrates the third anniversary of the Charter. We've come a long way in that time – from an initial membership of 51 large constructors, insurers and PMOs, we now boast almost 350 members, many of whom are small to medium businesses. The Charter started as an idea with some influential contacts and has grown into a highly effective organisation that's had a measureable impact on health and safety across the rebuild. Accident rates are falling, ACC claims are improving and awareness, engagement and safety behaviours are significantly better.



One of the reasons for the Charter's success has been its commitment to engaging with members. From the outset we were determined that our members would drive our direction and focus. This approach is evidenced by the Assessment tool – you use it because it helps you benchmark your health and safety systems, structures and processes. Also, the Charter Working Groups use the results to understand the issues facing our members in order to develop the Charter initiatives, tools, resources and targeted events.

One of the main ways the Charter engages with its members is through events. We've hosted a huge range of breakfasts, workshops and Quarterly Members' Events over the years and we often seek feedback to ensure we're delivering to your needs. For example, you've told us the Quarterly Events are valuable but the formal part needs to be shorter with less slides and you want more time for networking.

So, when you turn up for the event on 31 August, you will notice some changes. We've condensed the event into one hour – you'll still get the same networking opportunities and refreshments at the start and end of the event, but the formal part in the middle will be fast-tracked. I'll do a very quick Charter update, followed by the main event – the guest speaker - then we'll have a Charter member talking about their health and safety innovation or success, ending with recognition for new members and celebration of Charter Champions.

I know it's only a small thing but these events are a great way to network with like-minded people. We are working hard to continue to make the Charter more useful and appealing to smaller businesses and your feedback gives us golden information to develop and improve the Charter so it can be more effective.

Reporting on your Levies

We'd like to say a big thank you to all of our signatories who have contributed to the Charter levies for the 15/16 financial year.

Overall we collected just over \$100,000. The majority of the levies went towards campaign and communications costs, which was what we had outlined in our initial budgeting. The new Charter website was a big part of that, and I hope you'll agree with me on just how useful and fantastic this update has been. The levies covered:

- Revision and upkeep of Charter website and members' area (\$40,000)
- Part of the cost of the Charter Officer (\$25,000)
- Revised Charter launch materials (\$15,000)
- Printing and design of other Charter materials (\$16,000)
- Quarterly event, video and photography costs (\$7,000).

We'd also like to thank WorkSafe and ACC for their significant contributions during the year – both agencies contributing approximately \$100,000. ACC funds this monthly newsletter (thank you!) and WorkSafe funded:

- Maintenance of the Charter performance and leadership assessment tools
- Hosting Charter Orientations
- Charter Officer (costs not covered by levies).

The levies will stay the same for this financial year (2016/17) and we will be aiming to increase the total amount collected by continuing to increase our Charter signatories.

- Drug and alcohol awareness.

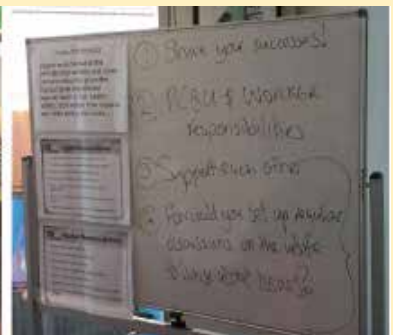
To try and cover off the above in a whistle stop tour we talked about the principles of the HSWA:

Often we are focussed on compliance and getting through the everyday minutiae. Take a moment to step back and consider what the principles of the HSWA are and what they mean.

For newly trained health and safety reps on the ground we talked about:

1. Sharing your successes – talk about the things that are working well, share a positive health and safety experience and build on the good stuff.
2. Familiarise yourself with PCBU and Worker Responsibilities so you can share this information with others. As a health and safety rep you are a leader, there are a lot of people not familiar with PCBU and Worker Responsibilities and it's a way for us to introduce these two important parts of the HSWA.
3. Build relationships with the people around you so that if you have to have a more challenging conversation at some point you have already established a rapport.
4. Support each other with issues that arise on-site – the chances are that the issue you find may be happening across more than one site.
